RESOLUTION #24 -18 STREET LIGHT REPLACEMENT WITH NEW TECHNOLOGY LED LIGHTING

WHEREAS: The Town of Stephentown, as a matter of Public Safety, provides street lighting services to selected intersections and highway areas in the town; and

WHEREAS: These current services are mandated and provided by the electric services company of NYSEG; and

WHEREAS: the Town Board is required to pass a resolution to approve any improvements or additions to the Street Light listing of the Town with the specifications to be installed; now therefore be it,

RESOLVED: that the Town Board of Stephentown, NY approve and request the electric services company NYSEG to remove existing fixtures and install new LED type fixtures to all lights in the Town of Stephentown account; and further be it

RESOLVED: that the Town Board of the Town of Stephentown recognizes that a certain amount of residual cost of older lighting fixtures will be reimbursed to NYSEG, presently calculated at \$3,414.42 for 29 cobra head light fixtures.

RESOLUTION #25 -18 CONTRACT FOR SERVICES WITH STEPHENTOWN EMERGENCY FOOD PANTRY

WHEREAS: The Stephentown Emergency Food Pantry, as a volunteer group, provides food to those town residents in times of extreme need; and

WHEREAS: These current services have been and are provided by the Stephentown Emergency Food Pantry from the Hall at the Stephentown Federated Church; and

WHEREAS: the Stephentown Federated Church has recently required that the Stephentown Emergency Food Pantry provide liability insurance coverage for use of the Church Hall: and

WHEREAS: the cost of such insurance will be in excess of \$500 per year: now therefore be it,

RESOLVED: that the Town Board of Stephentown, NY approve the expenditure of \$500.00 to The STEPHENTOWN EMERGENCY FOOD PANTRY, FOR THE SERVICES THEY PROVIDE TO THE NEEDY RESIDENTS OF THE TOWN OF STEPHENTOWN; AND FURTHER;

RESOLVED: that the Supervisor is authorized to establish a contract with the Stephentown Emergency Food Pantry stating that the funds are to be used only to offset the cost of needed liability insurance.
