RESOLUTION # 27-2019

RESOLUTION ADOPTED LOCAL LAW NO. 1 OF 2019 RESCINDING LOCAL LAW NO. 2 OF THE YEAR 2018 "AMENDING LOCAL LAW 1 OF THE YEAR 2010 CHANGING GRIEVANCE DAY

WHEREAS: the Town Board adopted Local Law No. 2 of the year 2018 to Amend Local Law No. 1 of the year 2010 Changing Grievance Day, and

WHEREAS: the Rensselaer County Tax Department has notified the Town that Grievance Day cannot be changed unless the Town's Acting Assessor is an Acting Assessor with another municipality, and

WHEREAS: the Town Board would like to pass a local law to rescind Local Law No. 2 of the year 2018, this Local Law will be titled Local Law No. 1 of the year 2019 "Relating to the Local Law No. 2 of 2018 Amending Local Law 1 of 2010 Changing Grievance Day", and

WHEREAS: said Local Law No. 1 of 2019 reads as follows:

Section 1. TITLE.

This Local Law Shall be known and cited as "Town of Stephentown Local Law No. 1 of the year 2019 Rescinding Local Law No. 2 of the year 2018 Amending Local Law 1 of the year 2010 Changing Grievance Day".

SECTION 2. LEGISLATIVE INTENT.

The Town Board held a Public Hearing on December 17th, 2018 in regards to a purposed Local Law No. 2 of the year 2018 titled Amending Local Law 1 of the year 2010 Changing Grievance Day. On December 17, 2018 the Town Board adopted Local Law No. 2 of the year 2018 by Resolution 66 of 2018, which amended Grievance Day to the fourth Wednesday in May. The Town Board determined that this date has been set forth

by the State and cannot be changed unless the current acting Assessor is an Assessor with another municipality. Therefore the date for the Board of Assessment Review is to hear complaints in relation to assessments will hereby remain on the forth Tuesday in May.

SECTION 3. AUTHORITY

This Local Law is adopted pursuant to Section 512 of the Real Property Tax Law.

SECTION 4. RESCISSION OF LOCAL LAW NO. 2 OF 2018

Local Law No. 2 of the year 2018 adopted on December 17, 2018, by Resolution 66 of 2018 and filed in the office of the Department of State on December 27, 2018 hereby is rescinded.

Section 6. Effective Date.

This law shall take effect immediately upon passage and shall be filed immediately with the New York State Department of State and the State Board of Real Property Services.
