L. Eckhardt: Next Monday, October 22nd, at 7:00pm we will be holding a Public Hearing on the Preliminary Budget and the Draft Master Plan here at the Town Hall at 7:00pm. 2% tax cap, we are currently about \$3,000 to \$4,000 over that putting us at 3.5%, we will take comment next week, and have a conversation whether to override or not.

- *S. Menhinick:* public informational meeting on the 414 Petition for the Library to be fully funded, Wednesday, October 24^{th} , at 7:00pm at the Town Hall.
- *L. Eckhardt:* November 6^{th} , it will be on the ballot for public vote to pay the Library \$95,000.00, the budget has to be to the County by November 20^{th} .
- *S. Menhinick:* Youth Commission Event for Halloween Trunk or Treating it will start at 3pm there is a party before at 1pm and a Costume Party at 2pm on October 28th, and Teen Party is on the 27th.

Discussion between T. Hanson, B. Baker, and L. Eckhardt on the Litigation between Baker v. Town of Stephentown. T. Hanson informed the board he will be occupying the homes, Baker informs there is still a litigation case in progress and a CO would need to be issued, L. Eckhardt informs both parties the Board cannot tell Mr. Hanson what to do. T. Hanson states the Town can only issue permits for the slab which the mobile homes are on and has never issued a CO for a Mobile home.
